## **Pre-Qualification Requirements**

- 1. The quotation has to be supported with the printed technical leaflet/literature of the quoted model of the item by the quoting party/manufacturer and the specifications mentioned in the quotation must be reflected /supported by the printed technical leaflet/literature. Therefore, the model quoted invariably is highlighted in the leaflet/literature enclosed with the quotation.
- 2. Parties who have supplied this item or equivalent item with same or higher specifications to at least two reputed Organizations /R&D institutes/Academic Institutions/Incubators in India with such equipment working satisfactorily can only be considered qualified. (Enclose documentary evidence).
- 3. The bidder shall not be blacklisted by any Government agencies/ Utilities/ Departments at the time of bidding. Letter from authorized signatory (as per the template in **Annexure-III**) on the letter head of SI regarding non-blacklisting.
