**NOTICE INVITING QUOTATION**

The Registrar of the Kerala University of Digital Sciences, Innovation and Technology, in Trivandrum, invites quotations from qualified tour operator firms for arranging travel-related services for the Rural Immersion Program for MBA students of Digital University Kerala for their visit from Delhi to Palgi, Kullu District, Himachal Pradesh in November 2025.

**Scope of Work:**

The selected agency shall provide the following services for 32 participants:

**Food, Accommodation, and Local Travel (Delhi to Palgi and back)**

- Period: 6 days (Leaving Delhi on 12 Nov 2025 to Palgi and return to Delhi on 17 Nov)
- Inclusive of all meals, lodging, and internal transport arrangements
- Accommodation to be provided on a twin-sharing basis in clean, hygienic and safe premises
- Transport to be arranged in well-maintained, air-conditioned vehicles suitable for hilly terrain
- All local permits, tolls, parking, and driver allowances to be included
- The safety of the participants during the journey and for the accommodation should be ensured by the agency.

**Schedule of the travel**

- Day 1: Arrival in Delhi; fresh-up arrangements at a hotel. Evening departure to Rangri by semi-sleeper Volvo
- Day 2: Visit to Keylong Village – Study on experiential tourism
- Day 3: Field research at Sissu Town – Exploration of community-based tourism
- Day 4: Visit to Farm Producers Factory at Panersa, Travel and stay in Palgi Village
- Day 5: Interaction with residents of Palgi, Evening departure to Delhi by bus
- Day 6: Arrival in Delhi; fresh-up arrangements at a hotel, Transfer to the railway station for the return journey

**Quotation Details:**

- Quotations must include a detailed cost break-up for food, accommodation, and local travel.
- The total cost should be inclusive of all applicable taxes and service charges.
- The agency should quote rates based on the lowest offer received.

Eligibility Criteria:

- The agency must have experience in conducting educational tours or group travel arrangements for academic institutions. Proof of conducting educational/study tours for PG students should be submitted.
- Must hold a valid GST registration and PAN.
- Preference will be given to agencies with prior experience in conducting tours in the Himachal Pradesh region and providing logistics in the location.

Submission of the Bids:

- The sealed quotations should be superscribed with "Quotation for Rural Immersion Program – MBA 2025" and submitted to the undersigned on or before 04 September 2025, 3:00 PM.
- Bids must be accompanied by a tender fee and a refundable EMD. The tender fee shall be Rs 708/- and EMD: Rs 3000/-

- Bid Validity: The submitted offer must remain valid for a minimum period of three months from the date of opening of the quotations
- Any changes or additional requirements during the event should be promptly communicated and agreed upon.
- Price quoted should be inclusive of GST, transportation, loading and unloading, and labour charges, etc.
- Within 15 days of receipt of the notification of Award / Purchase Order / Agreement, the Supplier shall furnish performance security in the form of a Bank Guarantee from/ Banker's Cheque or Account Payee Demand Draft for an amount equal to 5% of the PO value. This shall be refunded after successful completion of the work.
