their Head of Office or Department and keep it with them. If candidates fail to produce the No Objection Certificate as and when called for, his/her candidature will stand cancelled.

4. Candidates should ensure that the particulars furnished by him/her are correct in all respects. Anything not specifically claimed in the application against the appropriate field will not be considered at a later stage. No deviation whatsoever from the filled in data will be entertained. In case it is detected at any stage of the recruitment that a candidate does not fulfill the eligibility norms and /or that he/she furnished any incorrect/false information or has suppressed any material fact, his/her candidature will stand cancelled. If suppression of material facts or furnishing of any incorrect/false information is detected even after appointment, his/her service is liable to be terminated.
5. In case any discrepancy / ambiguity in the process of selection, the decision of the University shall be final and binding.
6. Consequent up on adoption of self- certification provisions, the University shall process the applications entirely on the basis of the information/documents provided with the application. The selection / appointment will be provisional and subject to physical verification of the documents.
